## Give More for Free

If you pay income tax, completing a **Gift Aid** declaration allows the Trust to reclaim the tax you have already paid. This adds an extra 28% to the value of your subscriptions and donations at no extra cost to you!

If your declarations covers donations you may make in the future, please notify the charity if you change your name and address while the declaration is still in force. You can cancel the declaration at any time by notifying the charity. It will then not apply to donations you make on or after the date of cancellation or the date you specify.

You must pay an amount of income tax and / or capital gains tax on your donations in the tax year (28p for each £1 Donated).

If in the future, your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that the charity reclaims, you can cancel your declaration.

If you pay tax at the higher rate you can claim further tax relief in your self assessment tax return.

If you are unsure whether your donations qualify for **Gift Aid** tax relief ask the charity or ask your local tax office for leaflet IR113 **Gift Aid**.
